Recess Regular Meeting

Call to Order Open Hearing Steve Lueck called the Open Hearing on the Amendment to the Zoning Code to establish zoning districts and regulations for cannabis and hemp businesses.

Kelly Kalmes, 19919 County Road 27, Rollingstone MN would like the city to have the most restrictions.

Eric Hilke, 210 2nd Street NE, wondered about the waste byproducts.

Howie Pichner, 119 1st St NE, welcomed a small business to town and would expand tax base.
